5. 2022 Annual Report

Terri advised that the annual report we are tabling this evening is structured around three key themes:

- The financial statements, for which we thank our Treasurer Siobhan Barker and Gillian Velupillay.
- The operational update in terms of what we achieved, for which we thank Sam von Gleichenstein, and all of the staff of the Neighbourhood House.
- The strategy going forward for which myself and the rest of the Committee of Governance are responsible.

Terri gave some highlights of 2022 as follows:

- Staff and volunteers kept the place running and beavered away at creating each and every community connection that could be managed.
- Childcare has gone from strength to strength and as a result this means that in 2023 that both rooms are
 open 5 days a week. This has not happened since I have been with the House since 2019. All by word of
 mouth.
- Adult classes are prospering with a mix of established and new programs. We have been tweaking timing to see what works best – full term or intensive programs and also experimenting with the content and the location of programs.
- Social programs are booming with our Digital Literacy program for Seniors attracting strong numbers and our partnership with Pantry 5000 strongly supported by members during what are frankly difficult times.

There were no questions in relation to the Annual Report including the financials. Terri asked for the reports to be accepted.

6. Appointment of Auditor:

Sam and Ken both thanked Terri for the leadership that she provided during her time as Chair and also thanked her for staying on the Committee as an ordinary member.

Sam then handed over to Ken, as the new Chair, to manage the rest of the meeting.

Photos of these totems feature heavily in our 2022 annual report.

Happy 40th Birthday to us!

As we celebrate our Ruby Anniversary, I reflect on this longevity. I believe listening to our community and meeting their needs maintains our relevance. We saw during the Covid 19 years how the House became an anchor for many in our community when things were uncertain. Who would have thought that Zoom 'Story time' for Gumnuts was a thing that would work? Or that I could learn basic Auslan, with a tutor based in Canberra and signing to fellow students online.

In current times, local families face increasing cost of living pressures. In response, we are providing high quality children's services that are affordable and sustainable. We have responded to Ukrainian war refugees by providing Barista training to give them skills to work in hospitality. We have provided 'Dignity' packs for homeless women. We have been screen printing bags for local organisations and events. We actively support local events like the Rotary Gnome and Fairy Festival and events with Mordialloc Traders.

The House is also a place of fellowship and laughter. Our Friday 'sewing group' is a testament to this. So too are our community groups. In any week more than 100 community members use the house for a diverse range of activities from scrapbooking to Auslan, English as Second Language to German classes, computers for seniors to yoga. The House lives through this activity.

I want to acknowledge all the hard work that our staff and volunteers put in each day to make all this activity happen in a seamless and professional manner.

I also want to thank all of my colleagues on the Committee of Governance for your commitment and diligence to the 'house'. I particularly want to acknowledge and thank our Deputy Chairperson Dylan Styles for his service to the 'house'.

Dylan will be moving from Melbourne for work

and lifestyle reasons and will resign from the Committee of Governance.

But, as we have learned changes are always on the cards. In the next few years the House will be challenged with the Level Crossing Removal and we will have to find innovative ways to respond and ensure the continued delivery of our programs.

But the one thing that will not change is that the heart of the House is people. We sincerely thank all of the participants, children and parents, staff and volunteers who each day make our House a home.

Anne attended Mordialloc College and then Frankston Teachers College (Primary teaching). She has taught many, many Refugees, E.S.L students and disadvantaged students in her 28years teaching in the inner city as a teacher. Anne has a keen interest in teaching English.

Anne has been a member of MNH for nearly 25years attending Sewing, Zumba running workshops and assisting with an intergenerational program which was run with Mordialloc Secondary College. In 2021 Anne was awarded Honorary Life Member for her dedication to our house. Anne has served on the Board previously and we are very happy she has returned to share her local knowledge with us.

2023 Plus Strategy

When the Committee of Governance had their strategy day at the House in 2023 we decided that the strategy was serving us well, but that we needed to get better at collecting data. Better data collection would enable us to demonstrate our impact to our community as well as enabling us to adjust our offerings to best meeting community needs.



Outcome

By 2030 it is known in the local area that Mordialloc Neighbourhood House provides an inclusive community hub that promotes well-being and community connections, with access to programs and services driven by the demand and responsive to the needs of the local area.

Priorities

This is a <u>three year</u> rolling plan, commenced in May 2022 and this is the September 2023 version.

Looking forward, our priorities continue to be:

Priority One Planning to thrive in the midst of disruption

Priority TwoSo that we can keep delivering to our community

Priority Three Whilst Keeping Our House in order

Each year Neighbourhood Houses Victoria survey all Neighbourhood Houses to capture data on what services they deliver and the impact these services have on their communities.

The most resent results show that for each hour that the Mordialloc Neighbourhood House was in use, we contributed \$330.46 of community value That is approximately \$500,000 of community value for the year.

This is what some of this community value looked like during 2023:

Childcare

Gumnuts and Koalas – delivered an average of 520 hours a week to 85 families during 2023 at an average rate of \$65 an hour. With over 90 % of families able to claim CCS. Making our childcare very affordable.

Ready for school – we delivered 10 hours over a 5 week to 8 families during 2023.

Adult and Community Further Education (ACFE)

Delivered an average of 4090 hours per term over four terms across two venues during 2023.

As ACFE provide a grant per student and our numbers have grown these classes are delivered at no charge to students.

MNH has welcomed our third ACFE students on board as a paid staff member.

Health and Well Being

Delivered an average of 800 hours over four terms to of Well Being activities.

Remedy First Aid issued approximately 20 number of certificates for training delivered from MNH and 2 for Mental Health Refresher certificates.

Youth Barista

Delivered 150 hours training to 15 students to assist them to find casual and/or ongoing work in our community.

Hobby Classes

Delivered an average of 480 hours over four terms to 27 students during 2023.

Successfully added an additional sewing class at the start of Term Three.

Venue Hire

Provided 11 community groups and local businesses with venue hire which equates to 160 hours of hire.

Employment

Provided 15 female staff a total of 8741.3 hours of employment during 2023.

Volunteer Hours

Accumulated 400 hours from our Committee of Governance and other volunteers during 2023.



Volunteering Story – What is involved in volunteering on the board

What is a Committee of Governance (COG)?

The Manager of the Mordialloc Neighbourhood House is the Secretary of the Committee of Governance (COG). All other COG members are volunteers who believe that spending time developing and monitoring the strategy and budget for the House and being a sounding board for the Manager is time well spent.

What is the time commitment?

The COG sorts out a meeting schedule for each year and we usually get together 12 times. Nine of these get togethers are general committee meetings and most of these are conducted via ZOOM. The other three are the

Course Delivery 2023

Last year the buzz word was "flexibility", this year it was "stability and consistence". We were able to offer full terms for all our classes this year which was fantastic. Thank you to all our Tutors who made sure all learners/ members had a wonderful year.



German Language

Our longest standing tutor, Marlis Caruana-Gerlach our German language teacher and tutor for 25 years was back at it again teaching a very full German class. Marlis continues delivering her class every Thursday evening and has also introduced a monthly weekend lunch table or as it is better known in German as a "Stammtisch" (translated means regular table) were the students get to practice their German in a social environment.

Computers

Joanne continued as our Computer tutor this year at Mordialloc Neighbourhood House and extended her teaching by delivering Computers at Clarinda community centre.

Our classes at Clarinda provided to be so popular that we need to add addition classes to fill the demand



ENGISH

ESL (English as a Second Language)

Joanne continued tutoring the ESL class covering English basics as well as exploring aspects of day to day life in Australia that don't readily translate. The ESL classes saw many new faces and a lot of interest for it to be also delivered at Clarinda.

In the later part of 2023 Natasha, who was one of our ESL students took over the teaching of this class.

Another success story is Vicky who attended our computer class for many years has become our Auslan teacher. The class caters for those who want to learn basic conversation and able to communicate with those who are hearing impaired.





Sewing

Every Friday our front room is filled with the tapping of sewing machines and laughter. This class was so popular that a second session was added in the afternoon. All levels are welcome to join these fun groups who want to share ideas and create new designs.

Art

Our social Art class is a group of very talented people who meet once a week to share their skills, have a chat and a cuppa weekly. This class is very casual and caters for all levels, bring your ideas and have some fun.



Barista

Leonie, was kept busy teaching the youth and adults the art of producing a perfect cup. This hands-on training aims to give students the confidence to gain employment within the hospitality industry. We partnered with Holmesglen's this year and trained over 50 students who are wanted to gain new skills to gain employment.

First-Aid

Mordialloc Neighbourhood House once again worked in partnership with Remedy First Aid, running a course to ensure we all had the most up to date qualifications. These courses run by Hayley and her team cover mental health, first aid for seniors, CPR as well as fully accredited first aid to those in our community. It is our aim to ensure that as many people in our community are able to perform CPR to ensure the safety of all.





Yoga and Meditation

Maggie has kept us all flexible and calm for many years now running an evening yoga class and a Thursday morning yoga and meditation session. We also opened this class up to the community during seniors festival and had wait list for the month.

We will continue as a Learn Local provider in 2024 and continue our partnership with Clarinda Community Centre and Holmesglen Institute of Tafe.

Workshops

Soup and Paint

Mordialloc Neighbourhood House brought out the artist in everyone this year. Our soup and paint class was a beginners guide to creating a master piece. This session was for those with or without painting knowledge to have a laugh, learn a new skill and enjoy a meal together.

Elder Awareness

In March we ran a Community Wellbeing Workshop with the focus on Healthy and Respectful Relationships. Our focus was on the bond between grandparents and family relationships and ensuring they felt valued with the family unit for all they contribute.

Children's Services

Our Children's services team had a very busy year. Open 5 days a week with over 70 children visiting each week and an average of 100 sessions a week.

The team welcomed a new staff, Sarah and Sam to help with our growing number of children in both the Koala and Gumnut rooms, which is once again a real testament to the amazing staff and care we give. It was the first time in many years that both rooms have operated 5 days a week with an average of 90 sessions a week. 




Children's Designs

This year was a very different feel to our morning tea in 2022 as we were personally touched with one of our fellow staff members going through her own personal battle. It was lovely to celebrate her positive results and raise money for this fantastic cause.

Kindness Bags - Pantry 5000

Once again, during the year we were a collection point for food donations for Pantry 5000, along with all sorts of food items. Food items donated included pantry staples such as rice and pasta and tinned vegetables along with seasonal items such as chocolate eggs at Easter and shortbread and other treats for Christmas.

Mordialloc Neighbourhood house along with many other houses are participating in the One Billion Stars project. This projects vision is to bring people together to help weave one billion woven stars to end domestic violence. We would like to thanks Gillian, Jodie and Terri who helped us reach over 1500 stars. The mission is to reach more people through the gentle practice of star weaving to help share stories and heal wounds and bring awareness to those who suffer daily.





Read to me 123

We continue to support Melinda Shelley, a volunteer who, understands that babies and children need books to have a real chance in life. Knowing that you first need to have books to be able to read to children, but that books are a luxury when you are struggling to put food on the table

123Read2Me currently provides children in low socioeconomic communities with FREE quality children's books through recycled books or new ones purchased with cash donations. The total value of books donated to date exceeds \$3,000,000.00 (replacement value). They promote reading to children and support the work of over 50 organisations, most o operating in the Frankston, Mornington Peninsula, Dandenong, Casey, Kingston and Bayside Local Government Areas of Victoria.

Mordialloc Neighbourhood House understand the importance of reading to children and children having access to books, we became a supporter and drop point for this organisation in 2023.

Digital Literacy for Seniors.

Every Wednesday afternoon our very "savvy" seniors come in with their device to learn new skills. Our tutor Jo, knows how to work step by step through their questions to make the most of the session without feeling over whelmed. This program was initially funded by a grant in 2022 and run in collaboration with Mordialloc Community Centre. This program has been such a success that we will continued to run it and will do again in 2024 at no cost to students with fundraising funds.

Kingston Market Bag Project

In partnership with Kingston Council and a grant from ACFE, lead by the amazing guidance of Ceri and with the help from volunteers from Mordialloc Community Centre and Mordialloc Neighbourhood House we produced these amazing bags for the Kingston Farmer Market which is held on the first Saturday of the month. Over the course of 3 months we produced over 1200 bags, which can been picked up at the market, reducing the amount of plastic that ends up in landfill.







Giving Tree

With the help of local 3195 business we were able to put together this amazing tree full of prizes. There was over 100 prizes ranging from a coffee to \$100 Bunnings vouchers and a Bike. All the \$500 raised will go into a community project which will be seen on the streets of Mordialloc early 2024.

Treasurer's report

In summary, the Mordialloc Neighbourhood House's Financial Statements results for the 12 months ending 31st December 2023 are as follows:

Profit/(Loss)	\$32,466	Equity	\$274,568

The 2023 Financial Statements present the 2023 and 2022 years as 12-month periods.

In 2023 the House returned a profit of \$32,466 against a forecast of \$17,462. This difference was mainly due to increased revenue from Childcare Services, which achieved a better than expected recovery in numbers once final pandemic restrictions were lifted.

This outcome places the House in a very positive financial position and the Committee of Governance is reviewing how best to allocate these additional funds to best improve services on behalf of Members.

The balance of cash in bank as at 31" December 2023 was \$391,550. The Committee of Governance has continued to adopt a low-risk position and maintain adequate cash buffers. This has been deemed necessary so that the House can continue to service the community, create jobs and meet its strategic objectives.

These very positive financial results are thanks to the teamwork, dedication and stewardship of our staff, led by our Manager and Finance Officer, implementing the strategic direction set by the Committee of Governance. I would also like to thank the organisations from across the government, private and community sectors, who continue to support Mordialloc Neighbourhood House. Grants support and other financial and in-kind assistances are a vital and immensely appreciated input which enable the House to continue supporting the community.

Note 1. Statement of significant accounting policies

Mordialloc Neighbourhood House Inc. ('the Association') is a not-for-profit incorporated association registered with the Australian Charities and Not-for-Profits Commission. The Association's sole activity is to act as the manager of a community social and welfare recreational centre. The Association did not carry out any trading activities during the financial twelve months other than those incidental to the above activity.

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the twelve months presented, unless otherwise stated.

Basis of preparation

These special purpose financial statements have been prepared for the purposes of complying with the Australian Charities and Not-for-profits Commission Act 2012 and the Associations Incorporation Reform Act 2012. The association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards. The Committee has determined that the association is not a reporting entity.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the disclosure requirements of AASB 101 'Presentation of Financial Statements', AASB 107 'Statement of Cash Flows', AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors', AASB 1048 'Interpretation of Standards' and AASB 1054 'Australian Additional Disclosures', as appropriate for not-for-profit oriented entities.

The financial statements for the year ended 31 December 2023 were approved and authorised for issue by the Members of the Committee of Management.

New and amended standards adopted by the Association

The Association has adopted all the amendments to Australian Accounting Standards issued by the Australian Accounting Standards Board, which are relevant to and effective for the Association's financial statements for the annual period beginning 1 January 2023.

Basis of preparation

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money value or, except where specifically stated, current valuations of non-current assets.

All amounts are presented in Australian dollars, unless otherwise stated.

Mordialloc Neighbourhood House Inc. Notes to the financial statements (continued) For the year ended 31 December 2023

The following significant accounting policies have been adopted in the preparation and presentation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

(a) Plant and equipment

Plant and equipment are carried at cost less, where applicable, any accumulated depreciation. The depreciable amount of all property, plant and equipment is depreciated over the useful life of the asset to the Association commencing from the time the asset is held ready for use.

(b) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks and other short-term highly liquid investments.

(c) Income tax

No provision for income tax has been made as the Association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(d) Accounts Receivable and Other Receivables

Accounts receivable are expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(e) Common Property, Buildings and Amenities

The common property is owned by the City of Kingston.

As Mordialloc Neighbourhood House Inc. is not the legal owner, no separate figure has been ascribed to the value of cost of the common property in the balance sheet.

(f) Right of Use Asset

A right-of-use asset is recognised in relation to the concessionary lease of the premises in the Association operates. The right-of-use asset is measured at cost and depreciated on a straight-line basis over the remaining unexpired period of the lease or the useful life of the asset, whichever is shorter.

(g) Revenue and other income

Revenue of the Association comprises fees from classes, fees from childcare, venue hire, government funding, interest donations and fundraising.

Revenue from contracts with customers and funding

Revenue is recognised at an amount that reflects the consideration to which the Association is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the incorporated association: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Interest revenue

Interest revenue is recognised using the effective interest rate method using an appropriate interest rate.

Volunteer services

The Association has elected not to recognise volunteer services as either revenue or other form of contribution received due to the difficulty of determining the fair value of volunteer services in a period which has been disrupted by the pandemic. As such, any related consumption or capitalisation of such resources received is also not recognised.

All revenue is stated net of the amount of goods and services tax (GST).

Mordialloc Neighbourhood House Inc. Notes to the financial statements (continued) For the year ended 31 December 2023

(h) Goods and services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented in the Statement of Cash Flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

(i) Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(j) Impairment of assets

At each reporting date, the Association reviews the carrying values of its tangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the Statement of Profit or Loss and Other Comprehensive Income.

(k) Current and non-current classification

Assets and liabilities are presented in the Statement of Financial Position based on current and non-current classification.

An asset is classified as current when:

- · it is either expected to be realised or intended to be sold or consumed in the normal operating cycle;
- · it is held primarily for the purpose of trading;
- it is expected to be realised within 12 months after the reporting period; or
- the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period.

All other assets are classified as non-current.

A liability is classified as current when:

- · it is either expected to be settled in the normal operating cycle:
- · it is held primarily for the purpose of trading;
- it is due to be settled within 12 months after the reporting period; or
- there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period.

All other liabilities are classified as non-current.

(I) Comparative information

When required by Accounting Standards, comparatives have been adjusted to conform to changes in presentation for the current twelve months.

(m) Significant accounting judgements, estimates and assumptions

The preparation of the financial statements requires the committee of management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and other various factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements. Actual results may differ from these estimates.

Mordialloc Neighbourhood House Inc. Notes to the Financial Statements (continued) For the year ended 31 December 2023

The Committee of management continually evaluates its judgements and estimates in relation to assets, liabilities, revenue and expenses. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current and future periods.

Coronavirus (COVID-19) pandemic

Judgement has been exercised in considering the impacts that the Coronavirus (COVID-19) pandemic has had, or may have, on the Association based on known information. This consideration extends to the nature of the products and services offered, customers, supply chain, staffing and geographic regions in which the Association operates. Other than as addressed in specific notes, there does not currently appear to be either any significant impact upon the financial statements or any significant uncertainties with respect to events or conditions which may impact the Association unfavourably as at the reporting date or subsequently as a result of the Coronavirus (COVID-19) pandemic.
